General Skilled Migration visa classes - (Lodged at Adelaide Skilled Processing Centre, ASPC)

- a) with occupation on the Critical Skills List, CSL = 12 months
- b) without occupation on the CSL = 36 months

Employer-sponsored visa classes - (Lodged in the relevant Centre of Excellence)

Including: Regional Skilled Migration Scheme 119, Labour Agreement 120, Employer Nomination Scheme 121.

Processing Time = 2 to 4 months

Business Visas - (Lodged at the Perth Offshore Centre)

Including: Business Owner Subclass 160, Senior Executive Subclass 161, Investor Subclass 162, State/Territory-Sponsored Business Owner Subclass 163, State/Territory-Sponsored Senior Executive Subclass 164 and State/Territory-Sponsored Investor Subclass 165

Processing Time = 9 to 12 months

Family Visas

For permanent residence applicants resident in the following countries, applying under the Family Visa stream, the Immigration Office assigned to your case and the average processing times are specified in the following table:
